# PRIVACY POLICY

This privacy policy governs your use of the mobile device software application, 21 Days of Gratitude, created by Jam3 Inc. ("Application").

# What information does the Application obtain and how is it used?

# **User Provided Information**

The Application obtains the information you provide when you download and sign in through Google Assistant.

# What are my opt-out rights?

You can stop all collection of information as well as delete all collected User Provided Information and Automatically Collected Information by uninstalling the Application. You may use the standard uninstall processes as may be available through Google Assistant

#### **Data Retention Policy, Managing Your Information**

We will retain User Provided Information for as long as you use the Application and for a reasonable time thereafter. If you'd like us to delete User Provided Information that you have provided via the Application, please contact us at assistant@jam3.com and we will respond in a reasonable time. Please note that some or all of the User Provided Information may be required in order for the Application to function properly.

### Children

We do not use the Application to knowingly solicit data from or market to children under the age of 13. We will delete such information from our files within a reasonable time.
